PROMOTION DETAILS

1. By participating in the **Broadsheet Access Black Friday Special** (Promotion), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 5, 71 Langridge Street, Collingwood VIC 3066 (Promoter).
3. The Promotion commences at **6:00am, November 12, 2025 and will close at 11:59pm, November 23, 2025.**
4. Entry is open to Australian residents only who are over 18 years of age at the time of the Promotion.

HOW TO ENTER

5. To enter these Promotions you must complete the application form including your first name, last name, email address and phone number.
6. This is a game of chance. There is no skill involved.
